The Board of Assessment Review (BAR) requests that proof be submitted substantiating your indicated value (pg.1, #7-property owners estimate of market value). Examples of such proof (see instructions) can be an appraisal by a licensed appraiser or a detailed list (3 or more) of comparable homes in your neighborhood that are <u>similar</u> in square footage, style and condition <u>that have sold recently</u> (see valuation date). The BAR convenes on grievance day each year and will meet throughout the summer months to review filings. You will be notified by mail of the BAR's determination prior to the issuance of the final assessment roll on September 15<sup>th</sup>.



## Key Dates on the Assessment Calendar:

May 1<sup>st</sup> (TAXABLE STATUS DATE): Assessments reflect the ownership and physical condition of the property as of this date. In addition, all exemption applications must be filed by this day.

**June 1<sup>st</sup> (TENTATIVE ASSESSMENT ROLL):** Date tentative assessments are made available (online and in office). This is also the date that CHANGE OF ASSESSMENT NOTICES are mailed for any property seeing a change in assessment including changes resulting from reassessment projects, building permits, inventory discrepancies, demolitions, etc. Please note, the Town of Mamaroneck mails "change of assessment" notices to ALL property owners, even if the assessment remains the same. If a property owner disagrees with the assessed value of their property, a grievance may be filed beginning on this day.

**June 1<sup>st</sup> thru THIRD TUESDAY in June:** Time frame to file a grievance. The Board of Assessment Review will convene on the third Tuesday in June (Grievance Day). Grievances can be filed by mail or in person at the Town Center. Grievances will not be accepted via email. All grievance applications, whether filed in person or by mail, **must be received on or before the third Tuesday in June**. Grievances received by mail after the third Tuesday in June, regardless of the postmark, will not be considered timely.

**September 15<sup>th</sup> (FINAL ASSESSMENT ROLL):** Date on which final assessments are made available and the first day to file Small Claims Assessment Review / Certiorari petitions. Final assessments include all changes made by the Board of Assessment Review.

**July 1<sup>st</sup> of Preceding Year (VALUATION DATE):** The Valuation Date is the date upon which the value of your property is based. In the Town of Mamaroneck, the Valuation Date is July 1st of the prior year. For instance, assessments on the 2025 assessment roll are based on the value of your property as of July 1, 2024.
